CALL TO ORDER BY THE CHAIRMAN AND ROLL CALL

The Oklahoma Cooperative Circuit Engineering Districts Board (OCCEDB) held a regular meeting on this day in compliance with the Oklahoma Open Meetings Act. READING OF THE MINUTES OF THE MAY 20, 2020 MEETING AND APPROVAL OR MODIFICATION OF THE SAME

The minutes from the May 20, 2020 board meeting were read individually. A motion was made by Dan Delozier to approve the May 20, 2020 minutes. The motion was seconded by Darry Stacy. DISCUSSION ON CED AUDITS AND OTHER COUNTY ISSUES BY THE STATE AUDITOR AND INSPECTOR

Cindy Bryd, State Auditor and Inspector, attended the OCCEDB meeting to discuss changes to CED audits. Her office will now be in charge of auditing CEDs'. She stated these will be operational audits and she will use the same set of staff to do all eight audits. She expects to have these audits completed sometime around February of 2021.

Cindy then discussed changes as a result of SB1888 passing this last session which sends 35% of CIRB funding to counties M&O. The Auditor's office has requested that the counties create a sub account, with the purpose of being able the track these funds and provide this information to Legislators if requested. She stated counties can do PO's directly out of this sub-account and use is for the same statutory purposes defined under the County Highway Fund.

Lastly, she discussed 1099's and the debate if ODOT or Counties should be doing the 1099 for CIRB right of way purchases. She stated there is nothing black and white in the IRS code but ultimately, if ODOT puts this language in their contracts with counties then counties will have no choice but to do the 1099's.

Randy Robinson discussed the auditing changes for CEDs' with the State Auditor and Inspector now performing their audits. With this change Randy recommended removing policy number one in the CED Revolving Fund Funding Application Policies. This policy required CEDS' to submit a yearly independent audit to the OCCEDB.
